Campus single entry points	The single entry point's mandate is to receive people who have information to transmit and to accompany them as they go through the process and not to conduct administrative or disciplinary investigations. This single entry point is readily accessible, guarantees confidentiality to the persons transmitting information and directs them to the appropriate resources. Info-social helpline 811	Free and confidential telephone consultation service. Calling 811 connects people experiencing psychosocial problems quickly with a professional resource. The service is available 24 hours a day, 365 days a year. The professionals working the phone lines provide advice and can answer questions dealing with psychosocial matters. They can also, if needed, refer callers to an appropriate resource in the health and social services network or to a community resource.	811, line 2
Help, information and referral line (24/7)	This help, information and referral line is for victims of sexual assault in Québec and their loved ones as well as for other people providing them with care and assistance. A team of specially trained operators receives the calls, assesses needs and refers victims to the appropriate assistance and protection resources. The line is free and accessible throughout Québec 24 hours a day, 7 days a week. The service is bilingual and confidential.	1-888-933-9007

Designated centre: medical-legal and medical-social evidence kit (24/7)	If you've recently been sexually assaulted, you're advised to go to one of the designated centres to receive medical and psychological support. Professional staff trained in dealing with sexual assault victims will receive you and accompany you in your efforts. Whether or not you make a complaint or have apparent physical injuries, you have the right to receive this aid. It is important for you to know that all steps of the intervention take place with your agreement. <p>Youth Protection Director (YPD) Direction de la protection de la jeunesse (DPJ)</p>	<p>In all regions of Québec, like here in the Gaspésie et des Îles region, it's the Youth Protection Director who sees to the application of the <i>Youth Protection Act</i>. The YPD receives all reports concerning children between 0 and 17 years of age who might need protection. The YPD is supported by a team of workers who assist in assessing the situation of these children and in making decisions to ensure their protection. The YPD makes decisions in the best interests of the child and in respect of their rights. <p>Criminal and Penal Prosecution Director Directeur des poursuites criminelles et pénales (DPCP)</p>	<p>Phone line providing information to sexual assault victims who are thinking about making a complaint to the police. This free and fully confidential service is for victims and for relevant aid organisation seeking to obtain information on how a complaint to the police is processed and on prosecution authorisation in cases involving sexual violence. This initiative is particularly for victims who might be reluctant to report a crime. It is important to point out that this service is not for individuals already engaged in the judicial process and who want to obtain information about their files.
